MAEAP Cost-Share Overview:



The CLMCD is pleased to announce MAEAP Cost Share will be available to help MAEAP participants cover the cost of basic items required for MAEAP verification. MAEAP participants are required to meet specific criteria in various areas to attain verifications. The Chippewa/Luce/Mackinac Conservation District MAEAP program has limited funds and will be available immediately following a risk assessment visit if needed.

General Guidelines for eligibility:

- √ Each farm is eligible for a maximum of \$350.00.
- √ Each farm needs to complete or have completed a risk assessment within the last calendar year.
- √ New verifications will take precedence over re-verifications.
- √ Funds will be available as a reimbursement for practices purchased between October 1, 2018 and September 30, 2019. Receipts will be required.

Whether you are MAEAP verified in one system or you haven't had a risk assessment on your farm yet, we encourage you to fill out the enclosed form and return it. This is a great opportunity to get involved and let us know what your farm needs. Some examples of items you could receive payment for:

- Soil Samples
- Fuel Pad
- Backflow Preventer
- Water Samples
- Spill Kit
- Drain plugs

Keep in mind that the program is still completely voluntary and confidential and these extra funds will simply provide more incentive towards MAEAP verification. Thank you for your time and consideration. We look forward to your input and hope to visit with you soon!
